Collection of Information

In order to use the Redlands Volleyball Association website or its services, we may require information from you in order to provide the best service possible.

All correspondence may also be collected and stored, particularly in regard to sales, supports and accounts, including email.

Any information collected by Redlands Volleyball Association is collected via correspondence from you or your company. This may be via telephone, email, mail, in person or directly through our website.

Use of Collection Information

Any details collected from Redlands Volleyball Association customers is required in order to provide you with our products and/or services, and a high level of customer service.

Correspondence is recorded in order to provide service references, and to assist in our staff/volunteer development.

Storage of Collected Information

The security of your personal information is important to us. When you enter sensitive information (such as Credit Card numbers) on our website, we encrypt that information using secure socket layer technology (SSL). When Credit Card details are collected, we simply pass them on in order to be processed as required. We never permanently store complete Credit Card details.

We follow generally accepted industry standards to protect the personal information submitted to us, both during transmission and once we receive it.
